# BIHARJUDICIAL SERVICE EXAMINATION SCHEME AND SYLLABUS

#### **SELECTION PROCESS:**

The Bihar Judicial Services Competitive Exam is conducted by the Bihar Public Service Commission involving three stages of the selection process viz., Preliminary (Objective) Exam, Mains (Written).

- Mode of application: Online
- Mode of exam: Offline
- Official Website: bpsc.bih.nic.in

Exam, and Interview. The selection process is similar to the various judicial services exams. The exam stages are:

- **Preliminary Examination:** The prelims exam is conducted for all the applicants who have applied for the exam. The exam has multiple-choice questions. There are two papers on General Awareness and Law.
- **Mains Examination:** The mains exam will be conducted for prelims qualified candidates. The mains exam has 5 compulsory papers and 5 optional papers out of which each candidate has to select 3 subjects
- **Interview:** A handful of candidates will be called for the interview. The interview will be taken by the committee decided by the commission.
- **Educational Qualification:** A candidate must have a Bachelor of Law degree from any institute or university recognized by the Bar Council of India.

## **ELIGIBILITY CRITERIA:**

- A candidate needs to be a citizen of India.
- A candidate needs to have the domicile of Bihar to get the reservation benefits.
- Applicants must have completed LLB from any recognized institute.
- The age of the applicants must be between 22 years and 35 years.
- The upper age limit for women and physically disabled persons is extended to 40 years.

## PRELIMINARY EXAMINATION

- Paper I consist of questions from General Studies (100 Marks.)
- Paper II consists of questions from Law Subject (150 Marks)

Candidates who get qualified in this exam will be called for Mains.
