#### SELECTION PROCESS:

1. Preliminary Examination (Objective Type)
2. Written Main Examination (Subjective Type)
3. Viva-Voce (Personal Interview)

**Exam Pattern:** The Exam Pattern will be as follows:

#### INTRODUCTION

The Examination for the post of Civil Judge II Class shall be conducted by the Chhattisgarh Public Service Commission (CGPSC).

**Stage of Exam:** Preliminary, Mains and Interview

#### ELIGIBILITY

- A person appearing for exam must have completed their graduation in Law from a recognized college or University.
- The minimum age required is 21 years and the upper limit is 35 years.
- Age relaxation provided to certain categories is mentioned below:

SC/ ST/ OBC Category Candidates of Chhattisgarh: 5 years

Women (SC/ ST/ OBC/ Unreserved): 10 years

Temporary/ Permanent Workers of Chhattisgarh: 3 years

#### SYLLABUS FOR PRELIMINARY AND MAINS

There shall be a screening test in the Online Preliminary Examination to shortlist candidates for the Mains examination. There is no negative marking in the Preliminary exam.

For the Mains Examination, the relatively more meritorious candidates from among those who appeared in the Preliminary Examination in the ratio of 1:10 having regard to the number of vacancies shall be called for Mains Examination (Written).

#### ONLINE PRELIMINARY EXAMINATION

The Online Preliminary Examination shall be of duration of two hours consisting of 100

objective-type questions from the following: -

- Code of Civil Procedure, 1908
- Code of Criminal Procedure, 1973
- Indian Evidence Act, 1872
- Constitution of India, 1950
- Transfer of Property Act, 1882
- Indian Contract Act, 1872
- Limitation Act, 1963
- The Chhattisgarh Rent Control Act, 2011
- Court Fees Act, 1870
- Specific Relief Act, 1963
- Registration Act, 1908
- Chhattisgarh Land Revenue Code, 1959
- Negotiable Instrument Act, 1881
- The Chhattisgarh Excise Act, 1915

### **MAIN EXAMINATION**

- Writing of Judgement and Framing of Issues in Civil Cases: 40 Marks
- Writing of Judgement and Framing of Charges in Criminal Cases: 40 Marks
- Translation: English to Hindi:10 Marks
- Translation: Hindi to English: 10 Marks

### **VIVA-VOCE (INTERVIEW)**

- Relatively more meritorious candidates from among those who appeared in the Mains Examination in the ratio of having regard to the number of vacancies shall be called for viva-voce to be conducted.
- The maximum mark for Viva-voce would be 15.
- A candidate belonging to the unreserved category must secure a minimum of 33% marks in the viva-voce and those belonging to Scheduled castes/Scheduled Tribes/Other Backward Classes shall be required to secure a minimum of 25% marks in the viva-voce. **Minimum 25% marks in the viva voce.**
