Prelims Examination Syllabus

The Preliminary Examination Pattern will be worth 100 marks and will last one hour and thirty minutes. One-fourth of a point is deducted for each wrong answer and one point is given for each correct answer. The exam contains a total of 100 questions.

Mains Syllabus

The main test consists of two mandatory papers and three optional papers. The following are the examination patterns for both mandatory and optional examinations. Paper I and Paper II are each worth 150 points. Paper I and Paper II each last 2 hours and 30 minutes. There will be two passages, one in English to be translated into Odia and the other in Odia to be retranslated into English.

Paper 1- General English

- An essay of about 150 words in length.
- One 500-word reading and five questions will be assigned.
- There are two passages to translate, each about ten lines long. The first is written in English and must be translated into Odia, whereas the second is written in Odia and must be retranslated into English.
- A quick summary of approximately 300 words

Paper 2- Procedural Laws

- The 1872 Indian Evidence Act
- The 1908 Code of Civil Procedure
- The 1973 Code of Criminal Procedure

Optional Papers

A candidate may choose any of the following three subjects:

- Law of Crime and Law of Torts
- Law of Property: Transfer of Property Act, 1882; Specific Relief Act, 1963; Indian Limitation Act, 1963
- Personal Law: Hindu Law; Mohammedan Law
