Chhattisgarh Judiciary Selection Process

The selection process for CGPSC Civil Judge 2023 Exam comprises three stages:

1. **Preliminary Examination:** Candidates who meet the eligibility criteria will have to appear for a preliminary examination, which consists of objective-type questions. The marks obtained in this examination will be considered for shortlisting candidates for the main examination.
2. **Main Examination:** Shortlisted candidates from the preliminary examination will be eligible to appear for the main examination, which will consist of written papers and essay-type questions.
3. **Interview:** Based on the performance in the main examination, candidates will be called for an interview. The final selection will be made on the basis of the combined scores of the main examination and the interview.
