Age Eligibility

- An applicant must be at least 21.
- No candidate may be over the age of 40 in the general category.
- There is a 5-year relaxation for women, SC, ST, or OBC candidates.

Educational Qualifications

- Candidates must have a bachelor's degree in law (LLB) from an accredited university.
- A 3-year or 5-year integrated course for the law degree is necessary.
- Final-year students are also eligible to apply for the examination.
- Candidates need to have their final graduation certificate before the main exam if they plan to take the RJS examination in the last year of graduation.

The interview will include various aspects, including the applicant's educational background, work experience, knowledge of current affairs, understanding of the law, and general knowledge. Additionally, candidates can earn extra points for their proficiency in the Rajasthani dialect and familiarity with Rajasthani culture.
